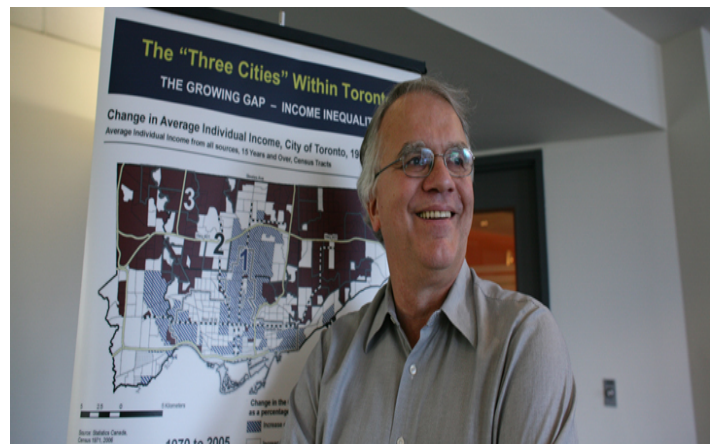
The academic keynote is David Hulchanski, Faculty of Social Work University of Toronto will be speaking on "Canada's growing socio-economic divide: Rising income inequality and polarization and what to do about it". Dr. Hulchanski has found "Compared to Western democracies, Canada ranks near the bottom in measures of income inequality and systems for addressing social need." In his presentation, Dr. Hulchanski documents social polarization trends since 1970 and their implications. He states: "Our wealth and prosperity can be more equitably shared, with the social economy playing an important role."
