Meet the Treasurer: Elizabeth Hicks

Gloria DeSantis interviewed Elizabeth Hicks, ANSER-ARES Treasurer, for this ANSER-ARES newsletter.

Gloria: Let us begin with you giving us a brief introduction of yourself.

Elizabeth: I am an Associate Professor at Mount Saint Vincent University teaching courses in accounting and taxation in the Department of Business Administration and Tourism and Hospitality Management; I am also a Chartered Accountant. I sit on the Board of Directors of the Centre of Excellence in



Accounting and Reporting for Co-operatives (CEARC). This organization is developing an international statement of recommended practices for co-operative accounting and reporting. I chaired the Management Board of the Centre for Women in Business, which assists women to start and grow their businesses. I chaired the board for the Uniacke Estate Entrepreneurial Education Society which mentored students in starting and operating their own businesses. Prior to MSVU, I worked as a professional accountant with government and two international public accounting firms, first in assurance and then in taxation. My husband and I live outside Halifax. We have two adult daughters and as of February 2011, a grandson.

Gloria: What originally drew your interest to the field of nonprofits and social economy organizations?

Elizabeth: My interest in the social economy grew out of my interest in green / environmental accounting. Traditional accounting reports are woefully inadequate in capturing the full true cost of conducting business therefore leading to poor decisions by organizations. Dr. Leslie Brown introduced me to co-operatives and I immediately saw that similar to environmental accounting, traditional accounting failed to adequately account for and report on the dual purpose of co-operatives, that is, the social along with the economic.

Gloria: Professionally speaking, what are you excited about now? What drives you?

Elizabeth: I am still very excited about improving accounting and reporting to reflect the triple bottom line, that is economic, social and environmental. Good decisions can only be as good as the information we have available. I am both interested in developing reporting for internal use by co-operatives to assist in strategic planning and self assessment and in developing standards for triple bottom line reporting to external stakeholders. This is important so that members as owners of their co-operatives can assess their co-operatives' performance in relation to their social and environmental goals and other stakeholders can gain an understanding of the true contribution co-operatives make to our communities.

Gloria: Why did you decide to get involved with ANSER-ARES?

Elizabeth: The work of Dr. Jack Quarter and Dr. Laurie Mook on accounting for not-forprofits initially inspired me to become involved in ANSER-ARES. I also find that the ANSER-ARES conference is an exciting opportunity to network and discuss current issues and topics related to my research with people with diverse backgrounds and expertise.

Gloria: What role do you see ANSER-ARES playing in the future?

Elizabeth: Currently, the annual ANSER-ARES conference and the new journal, ANSERJ, are wonderful venues for bringing together academics and practitioners interested in non-profits and the social economy to learn from one another. I see this as very important to continue and expand by encouraging more participation internationally. The current awards for students researching in the area of non-profits and the social economy are also very important for encouraging up and coming researchers in this area.

Gloria: On a more personal note, what do you do in your spare time?

Elizabeth: I really enjoy being outdoors in my spare time whether it is hiking, gardening, sailing and boating, cross country skiing, snow shoeing or cycling. When I have the opportunity I also enjoy travelling and visiting new places.

Gloria: What is your favourite book and why?

Elizabeth: It is so difficult for me to pick a favourite but one book I really enjoyed reading was "Trinity". I enjoyed the historical background in a fictional setting that provided insight into a very difficult social and political situation. It gives me hope that some of the struggles we experience today may come to a peaceful conclusion.

Gloria: What are you reading right now?

Elizabeth: At the moment I have just begun reading "A Thousand Splendid Suns".

Board Member Profile: Sherida Ryan



Sherida Ryan is the coordinator of a five year Social Science and Humanities Research Council of Canada CURA, Social Business for Socially Marginalized Groups. She is also the Knowledge Mobilization and Social Media Director for the Social Economy at the University of Toronto. Sherida teaches in the Faculty of Adult Education and Community Development at the Ontario Institute for Studies in Education, University of Toronto. Her research focuses on the interface of emerging information and communication technology, community development and social economy organizations. New issue of The Philanthropist



New book - High Ideals and Noble Intentions (2011) by Peter Elson

The relationships between governments and the voluntary sector in Canada are long-standing and complex. Beginning with an historical overview of developments in voluntary sector-government relations from 1600 to 1930, High Ideals and Noble Intentions goes on to explore more recent events and to bring present day policy and practice into focus. Peter R. Elson examines critical historical events in the relationship between the federal government and the voluntary sector which continue to exert their influence. He demonstrates through indepth case studies that these events are critical to understanding contemporary voluntary sector-government relations. Elson explores the impact of the regulation



of charities based on amendments to the 1930 Income War Tax Act; the shift from citizenbased program funding to service-based contract funding in the mid-1990s; and advocacy regulation changes in the 1980s. Elson's case is strengthened by an important and timely comparison between voluntary sector and central government relations in Canada and England. This historically informed comparative analysis provides the basis for practical recommendations meant to improve the future of voluntary sector-government relations across Canada. <u>http://www.utppublishing.com/High-Ideals-and-Noble-Intentions-Voluntary-Sector-Government-Relations-in-Canada.html</u>



William Beveridge was the architect of the welfare state in Britain and influenced similar developments throughout the world. His book, *Voluntary Action*, published in 1948 had its own impact in a variety of ways. This current book is the outcome of the 60th anniversary symposium which took place in London, England in 2008. This book will be of particular interest to historians, social policy researchers, political theorists, economists and educationalists. In addition to important chapters by British researchers, there are related chapters by researchers from New Zealand, Australia and Canada.
